**NOTIFICATION**

In pursuance of Rule 4 of Order II of the Supreme Court Rules, 2013, Hon'ble the Chief Justice of India has directed that the Supreme Court will be closed for the annual Summer Vacation from Monday, the 22<sup>nd</sup> May, 2023 to Sunday, the 2<sup>nd</sup> July, 2023 (both days inclusive) and will reopen on Monday, the 3<sup>rd</sup> July, 2023.
