NOTICE

The Hon'ble the Chief Justice of India has been pleased to direct that, in partial modification of Notice dated 05.07.2019, a fresh eligibility list of 468 lawyers, prepared as per seniority and prescribed roster by including eligible members from the Panel of 2021, be published for allotment of 234 new Lawyers Chambers in D Block, Additional Building Complex, on twin-sharing basis. The provisional eligibility list is accordingly published as **Annexure "B"** to this Notice, replacing the list that was published as **Annexure "A"** to the said Notice dated 05.07.2019.

In this regard, it has been further directed that the proposed allottees from Sl. 01 to Sl. 234 of the provisional eligibility list (*Annexure "B"*) may choose one co-allottee from amongst the remaining members of the said list of 468 lawyers, prior to 27.07.2022, and in the event that no such option is exercised for such allotment, on twin-sharing basis, the remaining blocks of two seats per Chamber will be allotted to the members from the provisional eligibility list by a draw of lots that will be done by 03.08.2022.

The SCBA and SCAORA, shall jointly prepare and submit list of all such allottees, who may have chosen co-allottee from amongst the other members of the provisional eligibility list, as well as of the remaining allottees, whose co-allottee may have been decided by a draw of lots, latest by 04.08.2022, for the matter to be processed further.
