A. TENDER

- 1. Three separate sealed envelopes should be used for submitting (i) "Earnest Money for Rate Contract of MISCELLANEOUS IT RELATED ITEMS AND ACCESSORIES", (ii) "Technical Bid for Rate Contract of MISCELLANEOUS IT RELATED ITEMS AND ACCESSORIES" (Annexure 'B') and (iii) "Financial Bid for Rate Contract of MISCELLANEOUS IT RELATED ITEMS AND ACCESSORIES" (Annexure 'E').
- 2. The tenderer is expected to examine all the instructions, Proformas' terms and conditions and specifications in the tender documents. Failing to furnish all information required by the tender document in every respect will be at the tenderer's risk and may result in rejection of the tender.
- 3. The tender must be received not later than the date and time specified for submitting the

same. In case the date of submitting the tender is declared as a holiday, then the next working day of the Registry will be treated as the due date of the tender.

B. TERMS AND CONDITIONS OF TENDER

- 4. The tenderer is required to quote their lowest rates per unit in **Annexure-'E'** for the above mentioned items for the contract period till November 2023. Technical Bids are required to be furnished in **Annexure-'B'**.
- 5. The tenderer is required to send his/her tender along with **EMD of respective amount as mentioned against each type of Miscellaneous IT Hardware as detailed below** by way of bank guarantee / demand draft drawn in favour of "Registrar (Admn.), Supreme Court of India" as **Earnest Money Deposit** for supply of miscellaneous information technology (IT) related items and accessories for a period till November 2023 (name of the firm, telephone number and name of the item may be written on the reverse side of the). No interest will be payable on EMD. If EMD is exempted, Certificate to this effect has to be submitted along with the tender documents.

If any tenderer wants to quote rates for all the types of aforesaid Miscellaneous IT Hardwares, the tenderer has to deposit EMD of **Rs. 53,835/- (Rupees Fifty Three Thousand Eight Hundred and Thirty Five only)**.

- 6. Earnest Money Deposit of the tenderers would be returned by way of RTGS/NEFT or cheque after the contract has been finally awarded to the successful tenderer. A copy of cancelled cheque is required to facilitate refund of EMD amount.
- 7. Tenderer having valid NSIC, MSME, Registry empanelment certificates shall be exempted from depositing earnest money. However, the copy of the same must be furnished

along with tender in Earnest Money sealed envelope.

- 8. Hypothetical or conditional Tender will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered. If the tender is withdrawn or altered by the concerned party at any time after it is submitted, appropriate action may be taken.
- 9. The Registry will deal with the tenderer directly and no middlemen/Commission agents etc. should be asked by the tenderer to represent the cause and they will not be entertained by the Registry.
- 10. The Tenderer shall give an undertaking (as per **Annexure** '**C**') that the firm/Partners/Directors/Proprietors have not been blacklisted and their business dealings with Central/State Government/Public Sector units/Autonomous bodies have not been banned/terminated on the account of poor performance.
- 11. In case of corrections, the same must be attested by the tenderer with full signature. Over-writing / over-typing or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the tender invalid.
- 12. The Registry reserves the right to make any change, at any time, in the terms and conditions of the Notice Inviting Tender and accept or reject any or all tenders wholly or partly without assigning any reason thereof.
- 13. The tenderer **shall quote rates both in figures and words** with blue/black ball pen. In case of any discrepancy between words and figures, the rates in words shall be accepted as correct.
- 14. All the pages of quotation including the documents submitted therewith must be duly signed and stamped failing which the offer shall be liable for rejection.
- 15. It is not binding on the part of the Registry to accept the lowest tender.
- 16. Each tenderer has to certify that all the terms and conditions are acceptable to him/her.
- 17. The Security deposit shall stand forfeited in case of breach of any of the conditions.

- 18. During the subsistence of contract, in case of breach of any conditions or deficiency in service, the Registry has a right to terminate the contract and to entrust the work to another contractor. The loss, if any, sustained by the Registry on that account shall be recovered from the tenderer.
- 19. Tenderers are required to fill the Technical Specifications Compliance Sheet as at **Annexure-'B'**. Financial Bids of only the technically-qualified tenderers shall be opened.

C. TERMS & CONDITIONS OF THE SUCCESSFUL TENDERER

- 20. The successful tenderer(s) shall have to give **Performance Security Deposit amounting to 5% of the total amount of the tentative <u>Purchase Order</u>** determined on basis of approved quantity mentioned in Financial Bid Sheet after adjustment of EMD amount, by way of Bank Guarantee drawn in favour of "The Registrar (Admn.), Supreme Court of India, New Delhi." which <u>will be released after two months of the successful completion</u> of the Rate contract period, <u>terms and conditions such as warranty applicable</u> or payment of the last bill, whichever occurs later.
- 21. The supply will be inspected by an Inspection Committee comprising of Senior Officers of the Registry and in case the final supply is not found in conformity with the approved specifications, the same will be liable to be rejected and the entire supply will have to be replaced with the quality exactly commensurate with the approved specifications at the cost of the tenderer. The decision of the Inspection Committee in this regard shall be final.
- 22. The supply as per the required specifications shall be required to be made within 2 days in the Registry (F.O.R.Destination) on receipt of Purchase Order; otherwise the Security Deposit may be forfeited along with any other action as may be deemed appropriate by the Registry. Non-availability of raw material shall not be accepted as a ground for delay in supply and shall equally be penalised.
- 23. The payment will be made only after full supply is received and accepted as per approved specifications **and after receipt of satisfactory report from Computer Cell of the Registry**. No part payment or advance payment will be made.

24. Validity: Quoted rates must be valid during the contract period. No escalation in respect

of materials, freight etc. will be allowed.

25. Successful Tenderer/s is/are required to fill the Undertaking of authenticity of

Suppliers for Miscellaneous IT Related Items and Accessories as at **Annexure-'D'**.

D. PENALTIES

26. If delivery is not made in time and the Registry is required to make purchase from

outside at higher rates, the loss sustained will be deducted from the E.M.D/Performance

Security Deposit of the Tenderer.

27. Irrespective of the fact as to whether or not the Registry makes the purchase from

outside, the Registry may impose penalty of 1% per week on total cost subject to a

maximum of 10%, for delayed delivery, if the delay is due to wilful laches or negligence of

the tenderer and if it causes financial loss or inconvenience to the Registry.
