Sealed tenders are invited, as per Proforma enclosed herewith as <u>Annexure-'A'</u> for **Rate Contract for supply and installation of UPS Batteries(Exide make) of different specifications on requirement basis for a period of two years** as per the specifications mentioned in **Annexure-'A'**. Approx 20 Nos. of 65AH/12V, 20 Nos. of 42AH/12V, 400 Nos. of 7AH/12V and approx 700 Nos. of RBP0043 of '<u>Exide SMF</u> <u>make'</u> batteries may be required during the contractual period of 2 years for use in the 15 KVA, 10 KVA, 1 KVA Online UPSs and 500-VA Line-Interactive UPSs respectively for the Supreme Court Registry.

A. TENDER

1. Tender may be sent by post sufficiently early so as to reach the Registry within time, or may be delivered to the undersigned. If tender is sent through Messenger, an authority letter from the tenderer with proof of identity may also be given to the Messenger so that he could show the same along with his own identity proof to the Reception Officer at Reception Counter No.37 for issuance of entry pass at the time of opening of tender.

2. Two seperate sealed envelopes should be used for submitting (i) "Earnest Money(EMD)" for Rate Contract for supply & installation of UPS Batteries and (ii) "Tender document/Financial bid" for Rate Contract for supply & installation of UPS Batteries.

3. The tenderers are excepted to examine with all the instructions, Proforma's, terms & conditions and specifications in the tender document. Failing to furnish all informations required by the tender document in every respect will be at the tenderers risk and may result in rejection of the tender.

4. The tender must be received not later than the date & time specified for submitting the same. In case, the date of submitting the tender will be declared as holiday by the Govt. of India then next day will be treated as due date of the tender.

B. TERMS AND CONDITIONS OF THE TENDER

5. The tenderers are required to quote their lowest rate per unit **under buy-back** with 2 years guarantee/warrantee for supply & installation of UPS Batteries (Exide make) with discount on bulk purchase, if any, and percentage of GST etc.

6. The rates quoted in the tender will remain unchanged during the contractual period of 2 years. Under no circumstances rate revision will be allowed.

7. The tenderers are required to send their tenders along with a Demand Draft of Rs.6,000-/- (Rupees Six Thousand only) drawn in favour of "The Registrar (Admn.), Supreme Court of India, New Delhi" as Earnest Money, which will be refunded without interest to the unsuccessful tenderers on their written request after awarding of the contract. Name of the firm, telephone number and name of item may be written on the reverse side of the Demand Draft.

8. Hypothetical or conditional tenders will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered. If the tender is withdrawn or altered by the tenderer at any time after it is submitted, appropriate action as deemed fit may be taken against that Tenderer.

9. The Registry will deal with the tenderer directly and no middlemen/agents/commission agents etc. should be asked by the tenderer to represent their cause and they will not be entertained by the Registry. The tender form is not transferable and agency shall not be permitted to transfer their rights and obligations to any other person/organisaion or otherwise.

10. Over-writing/over-typing or erasing of the figures which render the Tender doubtful or ambiguous are not allowed and shall render the tender invalid.

11. The Registry, in its discretion, reserves the right to reject or accept any or all the tenders, wholly or partly, without assigning any reason therefor.

12. The tenderer shall quote rates both in figures and words.

13. All the pages of quotations including the documents submitted therein must be duly signed and stamped, failing which the offer shall be liable for rejection.

14. If the successful Tenderer fails to fulfil his obligations, Registry after due notice to the supplier may blacklist the firm and the Performance Security shall be forfeited.

15. The OEM Company may submit a bid either in its own name or through any of the authorized dealer, who has to provide supply/services to the Supreme Court Registry.

16. The tender should accompany an undertaking of Authenticity as per proforma enclosed at **Annexure'B'**.

C. TERMS & CONDITIONS FOR THE SUCCESSFUL TENDERER

17. The successful tenderer shall have to give performance security deposit of 5% of the total value of tender after adjusting the amount of Rs. 6,000/-(Rupees six Thousand only) already deposited as Earnest Money along with the tender by way of Demand Draft in favour of "The Registrar (Admn.), Suprreme Court of India, New Delhi". The performance security deposit will be refunded after two months from the date of successful delivery/installation, and/or payment of their bill and/or expiry of warranty/guarantee period, whichever is later. The Earnest Mondey deposited along with the tender would be adjusted against the Security Deposit.

18. The UPS Batteries should be supplied strictly as per the specifications, which will be inspected by an Inspection Committee comprising of Senior Officers of the Registry and in case the supply is not fould strictly in conformity with the approved specifications, the same will liable to be rejected and the entire supply will have to be replaced with the quality exactly commensurate with the approved specifications at the cost of the tenderer. The decision of the Inspection Committee in this regard shall be final.

19. The delivery & installation of the UPS Batteries are to be done very expeditiously but not later than one week.

20. The payment will be made only after the full supply/installation is received/completed as per the supply order and accepted as per approved specifications.

D. PENALTIES

21. If delivery is not made in time and the Registry is required to make purchase from outside at higher rates, the loss sustained will be deducted from the Performance Security of the tenderer.

22. If the successful tenderer abandons the contract prematurely, or fails to perform his part of contract, the security deposit or any part thereof will also be liable to be forfeited.

23. Irrespective of fact as to whether or not the Registry makes purchases from outside, the Registry may impose penalty upto 1% of total cost per day, if the delay is due to willful latches or negligence of the tenderer and it caused financial loss or inconvenience to the Registry.

24. The Security Deposit shall stand forfeited in case of breach of any of the conditions mentioned herein and if the supply of the item is found unsatisfactory/not as per specifications.
