DETAILED TERMS AND CONDITIONS

- 1. The vehicle with chauffeur will be required initially for a period of two months and if the services are found satisfactory, the same may be continued for a further period of due year on the same terms and conditions or till the services are found satisfactory.
- 2. The chauffeur of the vehicle must be holding a valid licence to drive the vehicle.
- 3. The Registry reserves the right to curtail or cancel or to extend the validity of the contract at its own discretion.
- 4. All contractors who are providing similar kind of services for at least last three consecutive years will be given preference subject to production of documentary proof in respect of the same.
- 5. The contractor is required to enclosed the experiences of similar works in any of the Departments/ Autonomous Institutions/ Universities/ Public Sector Undertakings of Government of India etc. along with an undertaking as per Proforma marked as **Annexure -'B'** in respect of Non-Blacklisting.
- 6. The contractor is required to submit the security amount of Rs.5,000/- in the form of Demand Draft in favor of Registrar (Admn.), Supreme Court of India, New Delhi, which will be refunded only after two months from the successful completion of the contract and/or payment of their last drawn bill, whichever is later.

- 7. The Bid security submitted by the bidder will be forfeited in case (i) if at any stage, any of the document/ declaration/ information given by the contractor is found false; (ii) any lapse/default in honoring of the terms and conditions at any stage after submitting the tender; or (iii) the services are found deficient; and if the contractor withdraws his bid and/or services during the contractual period.
- 8. The contractor will have to arrange for the replacement of driver in case of any eventuality. The Registry reserves the right to ask the contractor for removal of any driver, who is not found competent or disciplined.
- 9. The Registry will be under no legal obligation to provide employment to any of the personnel of the contractor after expiring of contractual period and does not recognizes any sort of employer-employee relationship after such period.
- 10. The contractor shall indemnify the Registry against all other damages/charges for which the Registry may be held liable or pay on account of the negligence of the contractor or his staff or any person under his control whether in respect of accident/ injury to the person or damages to the property of any member of the public.

- 16. Proper log books must be maintained and payments will be made only on the basis of certified an verified entries of the same by the concerned officer.
- 17. The bills in triplicate shall be made by the contractor and should be addressed to Registrar (Admn.J/Tr.), Supreme Court of India, New Delhi.
- 18. The Registry also reserves the right to vary the number of vehicles hired as well as to relax the terms and conditions in the public interest.
