In the meanwhile, Mr. Varun K. Chopra along
with Mr. D. Kumanan and Mr. M.P. Parthiban, learned
counsel are requested to prepare a compilation
including written notes of submissions of the learned
counsel for the parties on both sides. The
compilation shall be circulated on or before
10.02.2022.

In view of the importance of the matters and
the implications on large number of students and on
appointments to be made to public posts, we make it
clear that no adjournment shall be granted.

In the meanwhile, the interim order passed by
the High Court on 25.08.2021 shall continue.

We make it clear that the admissions and

appointments that are already made shall not be disturbed till the matter is heard finally. No further admissions and appointments shall be made till 15.02.2022.
